## INFORMATION FOR STALL HOLDERS

- The market will be held on July 1<sup>st</sup> 2017 from 10.00am-4.30pm.
- Set up time will be from **8.30am-9.30am**. Stall holders need to be ready to trade by 10.00am.
- The market will be held indoors at the Colac Otway Performing Arts and Cultural Centre (COPACC), 95-97 Gellibrand Streets, Colac.
- A table and chair will be supplied for stallholders. Please refer to application form for other requirements
- Some selected work may be displayed in display cases for the duration of the event as decided by the artist and COPACC Management.
- Tax invoices will require your name, address, bank account details, ABN and the sales amount less commission. If you are not registered for GST a supplier statement will need to be submitted with the invoice.
- Stall-holders must ensure their stall is staffed for the duration of the market. It is possible to share your stall with another stall-holder; friends and family can help out too.
- We do not provide EFTPOS and credit card facilities. Transaction of sales are the responsibility of the stall-holder.
- There is no ATM in COPACC - the nearest is in Murray St Colac (main street) or Safeway Supermarket (opposite COPACC) and Bendigo Bank in Bromfield Street.
- There is a loading bay and trolleys for heavy items.
- COPACC staff will direct you to your stall and provide assistance where necessary.
- Stallholders will need to ensure all electrical items are tested and tagged prior to the day.
- In the event of an emergency, COPACC reserves the right to seek appropriate medical attention.
