## Selection

Artists will be notified of their selection by 5pm on June 12, 2017.

If your artwork is accepted for this exhibition, an entry fee of \$10 per item will be payable to COPACC and a 33% commission is payable on sales. Selected artwork needs to be delivered to COPACC on Monday, June 26, or Tuesday, June 27, 2017 between 10am - 2pm and collected on Monday, July 23, 2017, between 9am and 12 noon.

## Art Prize Terms and Conditions of Entry

1. Entries are open to all artists working in fibre and textiles
2. Artists are encouraged to CrossXpollinate and collaborate on a work of art
3. Entries must be the artist/artists' original artwork
4. Artists may enter more than one work
5. All entries must be submitted by 5pm June 1 2017, and include all required entry details.
6. Confirmation of entry will be via email to entrants once the entry form is received.
7. Artists will be notified by 5pm on June 12 2017 if their work has been selected for exhibition.
8. Selected artwork is to be delivered to COPACC between 10 am and 2pm on June 26 and 27, 2017. No entries will be accepted after this date.
9. All artwork must be clearly labelled with the artist's name, title of work, price and a contact number.
10. All entries must be ready for display. Please notify us if there are any special requirements around the display of the work.
11. COPACC reserves the right of selection, this includes, but is not limited to, the right to not exhibit any work unsuitable or unsafe to display, if it does not meet the terms and conditions of entry or does not meet the required standard for display.
12. Whilst all care will be taken with the handling of artwork in relation to the CrossXpollination Art Prize and exhibition, neither COPACC, staff or volunteers will be responsible for any loss or damage to artwork for the duration of this exhibition.
13. Artists whose artwork is selected for exhibition must have public liability insurance. If you do not have this, we can provide it at no charge upon completion of a public liability registration form available from COPACC.
14. Transport to and from the exhibition is the sole responsibility of the artist and artists are advised to obtain their own insurance for their artwork if they so desire.
15. The judges' decision is final and no correspondence will be entered into.
16. All artwork will be on display from the July 1 - 23, 2017
17. The *by invitation* opening of the exhibition will take place at COPACC on Friday June 30 2017 at 6.30pm. The Non-Acquisitive and Encouragement Awards will be announced and prizes awarded at this event. The winner receives \$500 and the Encouragement Award Recipient receives \$250. The winner of the People's Choice Award will receive \$250 , and will be notified at the conclusion of the exhibition.
18. Collection of artwork must take place on Monday, July 23. Artwork will be available for pick up between 9am and 12pm on this day. Any other arrangements must be organised with COPACC prior to this date.
